IRRIGATION TIMER REBATE APPLICATION

Use this rebate to replace your existing irrigation timer with a WaterSense certified timer. These timers reduce your water bill by using weather data to modify the runtimes on your timer. Some timers even include an app for your phone.

TAKE THESE 4 EASY STEPS:

1. Check to see if you are eligible for this program—see green box at left.
2. Install a WaterSense certified irrigation timer. (Timers must be set to the weather tracking service.)
3. Complete the digital application (fill out the PDF form), print, sign, and send along with a copy of the receipt and a recent copy of your water bill using one of the following methods:
